Soros created the foundation of the Open Society Foundation in the early 1980s in former socialist countries. This begins in his native Hungary. It attracts dissident people; the opening of Hungary to the West accelerates the fall of the Berlin wall.

#### The processes in The Eastern Europe

The very process of disintegration of the Communist system was used as much as possible by Soros in the early 1990s, for making foundations and imposing ideas for an open society. Foundations are established throughout Eastern Europe. Actually, through these foundations, this is a platform to create parallel structures in these countries that create chaos. The slogans are for a multi-party system, for the democratization of societies, Independent civil associations and organizations, non-governmental and organizational, often co-financed by the rules themselves, are set up. Soros 1979 grants \$ 3 million annually for Solidarity in Poland. Nowadays it turns out that all these members of Solidarity are agents of the state services. Soros created 1979. and the Open Society Foundation. He finances dissidents from the Charter -77 in Czechoslovakia, as well as academician Sakharov in the Soviet Union. The scheme is clear - attacking companies, national currencies and entire governments and states, weakening them in currency and financially and economically, bringing them to the brink of survival, and then fast-tracking and subsequent sale with the realization of huge profits. Funded the creation of independent media and supporting movements that ultimately serve him and his goals and aspirations and plans.

Andrew Gromika in the Soviet Union gives a green street to Soros' methods and actions. In Bulgarians, the commune, Andrei Lukanov, gives a green street to the "Open Facade".

In the Czech Republic, Soros maintains Vaclav Klaus. In Russia Gaidar and Yavlinsky. As Gaidar and Yavlinsky push Rousseau into profound economic, social, political, and other ways, giving the green light to the penetration of Western capital that buys the state of origin and makes them dependent. Soros's goal is to master politically and economically the former "communist" Eastern Europe in order to gain from it.

That is why he started building an open society in a communist Eurasian Europe back in the 80s of the 20th century, creating a foundation of the same name in the United Kingdom. This foundation is a symbol of dissidents and dissent thinking, which helps the country to transition to a multipurpose system. The multiparty system creates insecurity, chaos in every government. With the real breakdown of the Communist system in Eastern Europe, Soros's open society system is at its peak. Soros creates foundations in all the countries of East Europe, where hundreds of millions of dollars are poured for the "democratization" of the political and state system of the former communist countries. "Independent" Civic Councils and Organizations are set up. Consequently, an "open society" begins to serve only the goals of its creator. The Open Society system is evolving and becomes a "closed society" - a "closed system" in which only selected people - precisely defined for the purpose of the creator receive scholarships abroad. In Poland, the Open Society Foundation is called "Stefan Bartoni", the name of a Polish king who defeated the Russians in battle. In Urraina Soros, he helped Leonid Kuchma to take power. It openly calls for NATO to bomb Serbia. Actually, in the last 2018 years. Soros calls on the European Commission to pay billions for the European Refugee Wave and to finance billions of Africans. These and other money will be stolen by the undercover companies and agents. 1991 Soros gives the opposition \$ 100 million to take down Slobodan Milosevich, the real result is 2000. Milosevic was shot down by the USSR and with the help of Soros. In China and Belarus, Soros hits a stone.

Under the slogan of charity, Soros started 1979. granting \$ 3 million a year to Solidarity4 in Poland, to "Charter-77" in Czechoslovakia, to Academician Andrei Sakharov in the Union of Councils.

- In 1996, Russian ruble bands at levels of 5560 rubles per dollar,
- 1997 the ruble falls to 5960 rubles per dollar. The government made a denomination and on January 1, 1998. the ruble was \$ 5.96.
- On 17 August 1998, Russia announced its technically indebtedness to its domestic debt of 40 billion dollars and ended its support for the ruble on the same day. Then the Central Bank of Russia had reserves of \$ 24 billion. The stock exchange and the ruble lost more than 70 percent, and almost a third of the country's population lost its savings.
- This is the scheme - SMALL CURRENCY RESERVES - the currency of the respective country is being withdrawn, because of the lack of support, the CENTRIFUGAL DEVELOPMENT OF THE DEVALVATION is set and a currency crisis is created.

The results in society - emigrants of a million Bulgarians abroad, the educational system in Bulgaria is ruined as a result of the proposals for "reforms" in education by the Open Society.

All this has an impact on life, causing changes in medical practice, the military industry, public organizations, sex, and others. Until a new theory suddenly appears and does not "falsify" or reject it.

This is Popper's philosophy. It is limited and burdensome. That truth exists and may have a relative existence does not mean that it is relative. Truth is insecure, so science is vulnerable. But that does not mean that the truth is inaccessible. The existence of truth is evidenced by human progress in all areas: science, technology, society, politics.

- Popper turns criticism - ie. the exercise of freedom - the basis of progress. Without criticism, without the possibility to "falsify" all the assurances, there is no progress in science or in the fulfillment of social life.
- If people do not have the freedom to question and test the validity of all theories that promise some sort of solution to the questions before them. Everything that promotes Popper is a fiction that does not rest on rational intelligence.
- Then, myths, religious and other exhaustions come to be honored instead of rational truths.
- . Ie. the exercise of freedom is a fundamental right of reason, of culture, of science.
- Popper transforms freedom as a prerequisite for man's life. Popper defines the three worlds: the first world is that of things and material objects, the second is the subjective world of thought, and the third is that of the works of the spirit.
- The difference between the second and the third is that the second one is built up of the individual's individual subjectivity of the individual, the ideas, the images, the perceptions, the realms, while the products of the third one, though created by the subjectivity, have become public- scientific institutions, legal institutions, ethical principles, art, culture.
- The birth of the critical spirit breaks the walls of the closed society and exposes the person to a full-blown experience: personal responsibility. Freedom, daughter and mother of rationalism and of the critical spirit is a heavy burden on the shoulders of the human being.
- Popper says that with the simultaneous birth of the open society, in which intelligence has replaced the irrational, the individual has become a true person in history, and freedom has begun to displace the former bondage.
- But here is the criticism of Momchil Dobrev that there can not be just freedom without the legal, ethical, moral norms on which a society is built.
- No base, no skeins, no foundation, no building collapses.
- Thus, Popper's theory of decay for a "free open society" collapses.
- This is a chimera that is used in the wrong direction by Soros and a company.
